Learning Objectives # 1: Parents will learn about the District's six LCAP goals from a Local District and school site perspective.

Learning Objectives #2: Parents will gain resources and skills to collaborate with their school site leadership to support student achievement investments adopted for highest need students (EL, low income, foster).

Learning Objectives # 3: Parents will increase their awareness and engagement on the role of the Parent Advisory Committee (PAC) and the LCAP.

Projected Outcome # 1: Local District parents will prepare feedback for the District's LCAP.

Projected Outcome # 2: The PAC members will receive the feedback from parent leaders elected from their own Local District regarding the six LCAP goals, and the PAC will form comments based on the Local District feedback.

Projected Outcome # 3: The Superintendent will receive these comments which reflect the input of numerous schools from throughout the District.

Rationale for Local District LCAP Structure

Parents expressed the inconvenience of having to leave their local areas to attend meetings at the Office of Parent and Community Services. PAC members requested a decentralized model for future PAC meetings.

LCAP family engagement will increase from 55 parent members to over 350 members.

PAC members expressed concern that parents at the schools were unaware of the work done by the PAC and the support provided to the schools by LCAP funds.

Local District LCAP Study Group Membership

Local District LCAP Study Group will consist of at least 2 parents from each school, current PAC members and 1 Board Member Representative. The parents must be self-selected or selected by other parents. This can happen during a school event such as Back to School, Annual Title I Meeting and Coffee with the Principal, Other parent meeting.

Local District LCAP Study Group Responsibilities

The Local District LCAP Study Group will review the 6 LCAP goals. To ensure consistency of message, Central Offices will develop presentations for the Local District staff to present to the Local District LCAP Study Group. Local District Superintendents will determine which Local District staff will conduct the presentations to the Local District LCAP Study Group. Local District LCAP Study Groups will develop five feedback responses for each of the six LCAP goals. The feedback will be submitted to the PAC. The PAC will review and synthesize the feedback into 5 comments per LCAP goal to be submitted to the Superintendent. The Local District LCAP Study Group participants will elect new members to the PAC in January to fill existing vacancies.
