Effective Communication with Parents/Caregivers

around LAUSD's Student COVID Vaccination Policy

Conversations on this topic may be sensitive and/or complex. It might be hard to know precisely what to say, and how to say it. This document complements the <u>script</u> for vaccination conversations that has previously been shared, by providing tips about how to approach these conversations.

Adopt a Person-Centered Approach

It is critical that we take a person-centered approach to our outreach efforts. Individuals may have strong feelings and/or beliefs on this topic, and we will be more effective in building a connection with them if we listen authentically to their viewpoints and validate where they are coming from.

Here are a few questions that we may ask ourselves to confirm that we are taking a person-centered approach...

- 1. Do I listen more than I talk?
- 2. Do I ask permission to give information?
- 3. Do I recognize and acknowledge any mixed/conflicting feelings I hear?
- 4. Do I seek to understand this person?
- 5. Do I summarize for this person what I'm hearing?
- 6. Do I value this person's perspective?
- 7. Do I honor this person's right and ability to make their own choices?

What Topics Should I Cover or Avoid?

As you approach these conversations with a person-centered mindset, you may also have questions about what specific topics should be discussed or avoided. Keep in mind that our primary role is to support each family with developing a plan for continued access to education in January; it is not to provide medical information or personal opinions about the vaccine.

You may provide resources to families (with their permission) to help them access vaccinations, medical services, basic needs, mental health services, or technical assistance related to the above (access to a medical provider for consultation, transportation to a vaccination site, technology access to upload a vaccination record or medical exemption to the Daily Pass, conditional admission support, etc.).

However, if an individual has medical- or health-related questions or concerns related to the COVID vaccination, you should encourage them to talk to their child's health care provider.
