- (a) DTaP/DTP when given on or after 7th birthday meets the Tdap 7th grade requirement.
 - Enter the immunization date in the DTaP/DTP immunization field in MiSiS; **NOT** in the Tdap field (BUL-1660.9, page 2)
 - ✓ Welligent immunization reports are programmed to capture the DTaP/DTP date given on or after 7th birthday to meet the Tdap requirement.
 - ✓ MiSiS and Welligent Immunization fields can accommodate up to 10 dates
 - ✓ Only 5 dates are visible on the immunization screen but, the other date fields are

accessible by clicking the pencil icon under Action

(b) Tdap date meets the DTaP/DTP requirement.

- Enter the immunization date in the Tdap immunization field in MiSiS **NOT** in DTaP/DTP field. DO NOT re-enter the same date in two different immunization fields. (BUL-1660.9, page 2)
- ✓ Welligent reports are programmed to capture Tdap given to meet DTaP/DTP requirement.
- 2. Enter the correct date/s based on the student immunization record. The immunization reports are programmed not to count *immunization date/s before student's birthday* (DOB) or date/s in the future. This is also true when the age requirement for a specific immunization is not met. For example, Tdap or DTAP immunization date/s before 7 years old, will not be counted towards Tdap requirement. This will make the student non-compliant. If the student immunization record contains date/s mentioned above, please consult with a School Nurse for follow up.
