## 2013-14 LAUSD "I'M IN" School Attendance Challenge Quick Facts

Challenge runs from November 2013 through May 2014. Grand prizes awarded in May 2014.

### Student Eligibility

- All current LAUSD K-12 students that are actively enrolled with 100% attendance for the month period specified are eligible to participate.
- The student must be present every day and excused/unexcused absences, tardies and partial absences will disqualify a student from eligibility for the specified month.
- Schools will be responsible for making corrections to student's attendance records on LAUSD MAX and will have up to the last day of each month to update records before the monthly data collection is completed.

### Student Prizes

#### **Monthly Drawing**

- K-12 students with perfect attendance for the previous month will be placed on an eligibility list and entered into a randomly selected drawing to receive monthly prizes.

#### **Grand Prize Student Drawing- May 2014**

- K-12 students with perfect attendance every month from *November 2013 to April 2014* will be randomly selected to receive a prize. *One prize per student.*

### Reward Distribution

Winners will be initially notified via School Principal by Pupil Services Unit and names will be posted on the 2012-13 LAUSD "I'm In" School Attendance Challenge website maintained by Pupil Services Unit.

Selection will take place on or around the 30th of the following month of eligibility, and winners will be announced approximately one week later.
