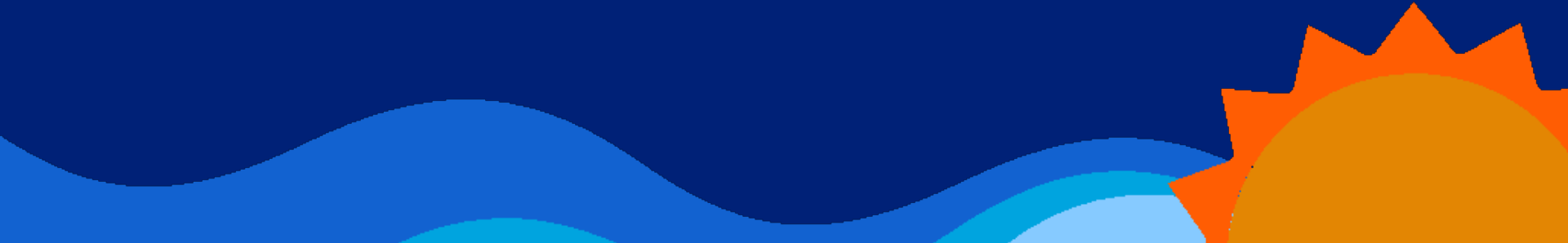

Student Equity Needs Index (SENI)



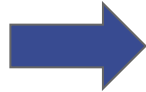
LAUSD allocates around \$700 million directly to schools as TSP funds through the Student Equity Needs Index (SENI), a set of academic and community indicators.

TSP funds are intended to close equity gaps for our students who are English learners, in foster care, and/or designated as low income.

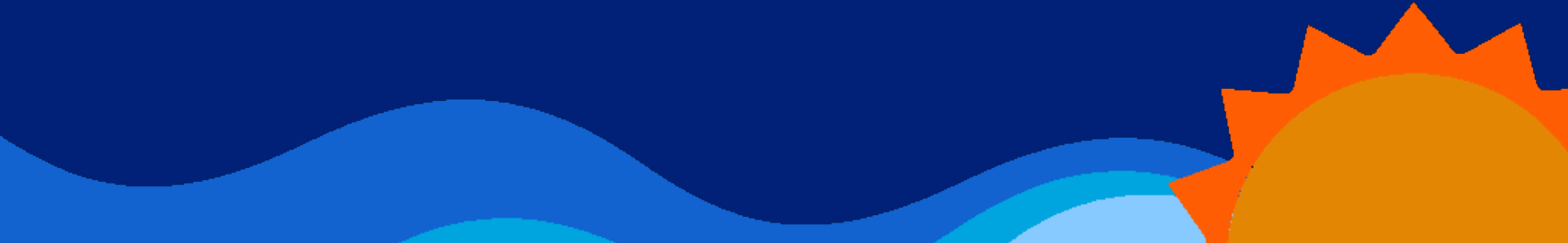

- Targeted Student Population (TSP) Plan is a companion to the SPSA
- TSP Plans are reviewed and approved by Community of Schools Administrators
- Purpose of the Plan is to articulate how TSP - SENI funds will be used for increased or improved services and programs to close equity gaps for students who are English Learners, Low - Income, and/or in Foster Care

# TSP Plan Compliance Checklist



## Instruction / Program Requirements

- ☐ Most school strategies include at least one position and one non-position item (a position is not a strategy in and of itself)
- ☐ All school-level strategies and actions clearly align to District Strategic Plan Strategies and Priorities
- ☐ At least one school strategy is aligned to the SENI Menu of Investments
- ☐ At least one school strategy is identified for a specific student group (not all students)
- ☐ Any school strategy that is designated as serving “all students, but primarily benefiting English Learners, Low-Income Students, and/or Students in Foster Care” must articulate how this strategy increases / improves services for targeted student needs
- ☐ Identified progress monitoring metrics are aligned both to the school strategy and to the specific student groups

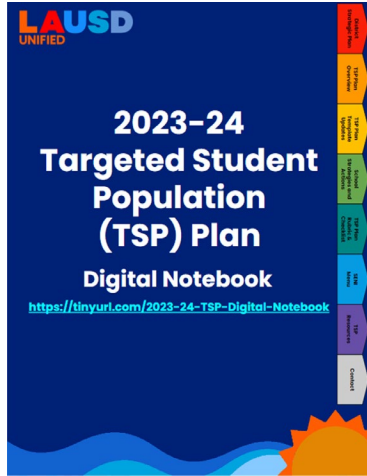
# TSP Plan Compliance Checklist



## Fiscal Requirements

- ☐ Entire new TSP Allocation has been budgeted in the Plan: Total TSP Funds Budgeted in Plan (Approval Page of Plan) is equal to Amount of TSP Funds Allocated to School in 10552 (Page 1 of Plan) - carryover funds are not included in the TSP Plan
- ☐ All Carryover Funds in 10552 have been moved to Program Codes 10947, 10948 and 10949: Program Code 10552 has a \$0 balance.
- ☐ Fiscal Specialist has certified that all TSP position costs appropriately reflect Potential Funding Variance (PFV) and any benefits adjustments
