### FLOOR COVERING SUPERVISOR

## **DEFINITION**

Plans, directs, and supervises the installation, repair, and maintenance of a variety of floor coverings, including tile, hardwood, soft, and resilient floor coverings throughout the District.

### TYPICAL DUTIES

Supervises and inspects the installation, repair, and maintenance of a variety of tile, hardwood, soft, and resilient floor coverings.

Confers with site administrators and other employees regarding problems associated with floor covering installations and repair.

Estimates labor and material costs and initiates requests for orders.

Prepares material lists for stock and non-stock materials purchased on annual contracts.

Consults with and advises contractors regarding problems.

Approves payment of contracts and job tickets for equipment and material.

Advises the Facilities Contracts Branch on the selection of vendors of non-stock materials or the use of special materials to be matched with former contracts for previously installed floor coverings.

Inspects contractors' work to ensure compliance with contract requirements.

Conducts investigations to determine reasons for problems and acts as a technical expert in legal cases and hearings.

Prepares a variety of reports related to floor covering installation activities throughout the District.

Prepares delivery schedules for shipment of materials to job locations.

Develops and maintains a long-range plan for floor covering replacement.

Performs related duties as assigned.

#### DISTINGUISHING CHARACTERISTICS AMONG RELATED CLASSES

The Floor Covering Supervisor supervises, schedules, and is responsible for floor covering installation, repair, and maintenance; advises school administrators and other District personnel on floor covering materials; and inspects floor covering work for completeness and safety compliance.

An Area Facilities Services Director is the administrative head of personnel assigned to perform routine and preventive maintenance, smaller construction projects, and custodial operations for a Maintenance and Operations local district.

A Senior Floor Covering Installer surveys various sites and plans and estimates floor covering work, orders required materials, and assists the Floor Covering Supervisor in coordinating and inspecting floor covering installation and repair.

### **SUPERVISION**

General supervision is received from an Area Facilities Services Director. General supervision is exercised over Senior Floor Covering Installers, Floor Covering Installers, Tile Layers, Tile Layer Helpers, Hardwood Floor Workers, and Maintenance Workers.

# **Special Physical Requirements:**

Ability to stand, walk, bend, crawl, reach overhead, kneel, balance, push, pull, and lift items weighing up to 100 pounds

### **ENTRANCE QUALIFICATIONS**

## Education:

Graduation from high school or evidence of equivalent educational proficiency, preferably supplemented by college, university, or vocational courses in supervision or completion of the Exceptional Supervisor Certificate Program I offered by Organizational Excellence.

### **Experience**:

Four years of journey-level experience in the floor covering trade.

#### Special:

A Facilities Planner Training Program Certificate is required by completion of the probationary period.

A valid driver's license to legally operate a motor vehicle in the State of California and use of a motor vehicle.
