### PROGRAM AND POLICY DEVELOPMENT ADVISOR - CONSTRUCTION PROGRAMS

### DEFINITION

Advises Senior District Management in the planning, implementation, and prioritization strategies of a construction program or programs.

### TYPICAL DUTIES

Strategizes, plans, formulates, directs, and implements the goals of construction program or programs.

Identifies complex problems resulting from District operational requirements and competing priorities and develops and implements resolutions.

Directs the analysis of demographic information, facilities conditions, and code requirements to determine and develop policies for prioritization.

Analyzes potential funding opportunities and advises senior leadership on the potential impacts and opportunities that should be considered in the prioritization of capital improvements.

Assures that the construction program and subsequent project development is consistent with State laws, Bond language, and District policies.

Develops policies regarding the implementation of a construction program as it pertains to the facility needs and impacts of Charter Schools and other instructional programs.

Renders expert consultation and advice to senior leadership to identify opportunities to align future facility capital improvements with existing and emerging instructional programs.

Liaises and coordinates activities with Educational Service Centers, Board Offices, relevant external stakeholders, and the Superintendent's senior leadership team on prioritization of capital investments throughout the District.

May represent construction programs before the Bond Oversight Committee, Board of Education and its committees.

Performs related duties as assigned.

## DISTINGUISHING CHARACTERISTICS AMONG RELATED CLASSES

The Program and Policy Development Advisor – Construction Program oversees the policy, goals, and prioritization strategies of a construction program or programs.

The Director of Facilities Planning and Development directs long range asset master planning, identifies requirements for new and existing schools, provides critical information for obtaining CEQA clearance, develops school designs, supports the site selection process for new schools or expansion of existing schools, and recommends procurement of services to obtain new facilities perform major modernization of existing schools.

A Program and Policy Development Specialist serves as a staff assistant to senior management by developing, coordinating, and monitoring studies relating to instructional programs and the District's strategic plan.

### **SUPERVISION**

The Program and Policy Development Advisor – Construction Program receives administrative direction from the Director of Facilities Planning and Development and provides administrative direction to lower-level management or administrative staff.
