765 SENIOR MANAGEMENT EMPLOYEES

A. Designation of Senior Management Positions

Under the provisions of Education Code Sections 45108.5 and 45256.5, the Board of Education may designate positions as senior management of the Classified Service. Employees whose positions are so designated shall be part of the Classified Service; however, they shall not attain permanent status in senior management classes. Senior management positions may include the fiscal advisor to the Superintendent and the highest positions that have District-wide responsibility for formulating policies or administering a principal District program area, as determined by the Board of Education.

Pursuant to Education Code Section 45108.7, the District as of May 9, 2006 has been granted waivers from the State Board of Education, for a total number of 73 positions that may be designated as Senior Management Positions.

- B. Selection of Senior Management Employees  
Positions designated as senior management of the Classified Service shall be filled from an unranked alphabetical list of persons who have been determined by the Superintendent to meet the minimum qualifications specified by the Personnel Commission.
- C. Seniority Rights  
Senior management employees shall earn seniority credit in accordance with Rule 740.
- D. Bumping and Placement Rights of Employees with Regular Status in the Classified Service
- If a senior management position is abolished in accordance with Education Code Section 45104.5, or the assignment of an incumbent in a senior management position is terminated, with 45 days' notice required by Education Code Section 35031, the employee shall be placed according to the following sequence:
1. In a position in the class to which the employee would be entitled if the position had not been designated as senior management
  2. In a position in a class to which the employee holds bumping rights, as provided in Rule 740.
  3. In a vacant position that is similar to the employee's former position in the Classified Service.
